- Jurisdictions with fewer than 1,000 registered voters----**No** reports are required.
 - Jurisdictions with more than 1,000 but less than 5,000 registered voters----File an **F1** (financial affairs statement) within 2 weeks of becoming a candidate. This is the only form required.
 - Jurisdictions with more than 5,000 registered voters----**Yes**, file F1 and C1 forms within two weeks of becoming a candidate. During your campaign, depending on how much money is spent, filing of other forms may be required.
